

**Exercise 2: Citation Form**  
(due October 12, 2007)

Based upon the information provided below, prepare citations for the following cases in ALWD form, as the citations would appear in an office memorandum.

- Note that parallel citations to official reporters are required only in documents to be submitted to a state court, *see* ALWD Rule 12.4(b), so you should not provide such parallel citations here.
  - Assume that the citations you are preparing will appear in citation clauses or sentences, and abbreviate words in party names according to ALWD Rule 12.2(e)(3). (That rule says that words listed in Appendix 3 *may* be abbreviated. For purposes of this exercise and other assignments in this course, however, treat that rule as requiring rather than merely permitting abbreviations. For example, in #2 below, abbreviate “National” as “Natl.”)
  - Unless otherwise stated, provide complete citations rather than short forms, but omit subsequent case history ordinarily required by ALWD Rule 12.8.
  - Use only the information presented here to prepare the citations; you need not look up the cases in printed case reporters or online.
  - The answer to #1 below is posted at [www.lawyeringskills.com/answer2](http://www.lawyeringskills.com/answer2). Check your answer there before completing the remainder of the exercise.

No. 1-01-2843. April 26, 2002. Illinois Appellate Reports, Third Series, volume 329, pages 1059 to 1063 (text of opinion begins on page 1060). Also reported in North Eastern Reporter, Second Series, volume 769, pages 142-145 (opinion begins on page 143), and Illinois Decisions, volume 263, pages 940-943 (opinion begins on page 941). Include a pinpoint (“jump”) citation to indicate that you are referring to material that appears on pages 1062-1063 of the case (page 145 in the North Eastern Reporter version, or page 943 of the Illinois Decisions version).

Reported at 126 Ill. 2d 411, 534 N.E.2d 987, 128 Ill. Dec. 542, and 16 Media L. Rep. 1214. Cite to material appearing on page 418 of the case (page 989 of the North Eastern Reporter version).

3. Bloom Township High School, K & M Plastics, Inc., Marshall Field & Company, and St. Therese Medical Center, Petitioners, v. Illinois Commerce Commission and Commonwealth Edison Co., an Illinois Public Utility Company, Respondents. Appellate Court of Illinois, First District, Fourth Division. No. 1-99-0625. Decided November 24, 1999. Reported at 309 Ill. App. 3d 163, 722 N.E.2d 676, and 242 Ill. Dec. 892. Cite to material appearing on page 174 of the case (page 685 in the North Eastern Reporter version).
4. Cite to material appearing on pages 1062-1063 (page 145 of the N.E.2d version) of *Saichek v. Lupa* (#1 above). Since you have previously cited to this case, use a short form citation here.
5. State Automobile Mutual Insurance Company v. Kingsport Development, LLC. Appellate Court of Illinois, Second District, April 5, 2006. Reported at 364 Ill. App. 3d 946, 846 N.E.2d 974, and 301 Ill.Dec. 371.
6. Patrick E. Dwyer v. American Express Company. Appellate Court of Illinois, First District, First Division, June 30, 1995. Reported at 273 Ill.App.3d 742, 652 N.E.2d 1351, and 210 Ill.Dec. 375. Cite to material on pages 744-745 of the case (pages 1353-1354 of the North Eastern Reporter version).
7. Cite to material appearing on page 423 (page 992 of the North Eastern Reporter version) of *Lovgren v. Citizens First National Bank* (#2 above). Since you have previously cited to this case, use a short form citation here.

Cite to footnote 7, which appears on page 1380 of the case (page 322 in the Pacific Reporter version, and page 63 in the California Reporter version).
